8. MATTERS FOR DISCUSSION

8.1 COUNCILLOR'S REMUNERATION: 2023/24 FINANCIAL YEAR (5/10/1)

The increased allowances and fringe benefits for councillors for the 2023/2024 financial year were promulgated in the Government Gazette 51407 dated 17 October 2024, as announced per Government Notice 5435.

The report to the agenda and appendices contains the financial implications for Swartland Municipality as a Grade 4 local authority – sufficient funds have been budgeted for in the 2024/2025 financial year to implement the increase retroactively.

The Speaker put the matter to a vote with a -

UNANIMOUS RESOLUTION

(proposed by cllr A K Warnick, seconded by cllr D G Bess)

- (a) That the contents of Government Notice 5435 as published in Government Gazette 51407 dated 17 October 2024 be noted, as well as the implications of same in respect of the increased allowances and benefits payable in respect of the 2023/24 financial year by the Municipality as a Grade 4 local authority, as explained in Annexure B to this report;
- (b) That cognisance be taken that adequate provision has been made in the 2024/25 operating budget in order to cover the increased allowances and benefits, and that the implementation of same thereof be approved, with retrospective effect from 1 July 2023;
- (c) That the consultation prescripts of the MEC for local government be complied with in order to obtain the latter's concurrence with the implementation of the amended allowances and benefits;
- (d) That, as soon as the approval of the Provincial MEC is received based on the late publication of the upper limit notice in the Government Gazette for the preceding financial year (2023/24) the payment be made as soon as possible, since the latter action cannot be considered an advance in terms of Section 167 of the MFMA, because it was already payable, and the payment is approved and supported by the Provincial MEC as well as the announcement in the Government Gazette;
- (e) That the Municipal Manager ensures that the information required in terms of Item 18 of the Government Notice be submitted to the MEC for local government, by no later than 16 November 2024;
- (f) That the Executive Mayor be mandated to notify the National Minister and the Department (Cogta) that the late publication, with reference to the 2023/24 financial year (Notice of 17 October 2024), has far reaching implications in respect of taxation, as well as the recording of transactions in the financial statements in a previous financial year.

8.2 COUNCILLOR'S REMUNERATION: 2024/25 FINANCIAL YEAR (5/10/1)

The increased allowances and fringe benefits for councillors for the 2024/2025 financial year were promulgated in the Government Gazette 51419 dated 21 October 2024, as per Government Notice 5446.

The report to the agenda and appendices contains the financial implications for Swartland Municipality as a Grade 4 local authority – sufficient funds have been budgeted for in the 2024/2025 financial year to implement the increase retroactively.

- (d) That, as soon as the the approval of the Provincial MEC is received based on the late publication of the upper limit notice in the Government Gazette for the current financial year (2024/25) – the payment be made as soon as possible, since the latter action cannot be considered as an advance in terms of Section 167 of the MFMA, because it was already payable, and the payment is approved and supported by the Provincial MEC as well as the announcement in the Government Gazette;
- (e) That the Municipal Manager ensures that the information required in terms of Item 18 of the Government Notice be submitted to the MEC for local government, by no later than 20 November 2024.

8.3 ADOPTION OF THE CODE FOR ETHICAL LEADERSHIP IN LOCAL GOVERNMENT (2/B)

The Code of Ethical Leadership in Local Government was drafted to provide guidance to leaders on how to deal with issues that have the greatest impact on ethical governance in municipalities.

The Municipal Manager confirmed that the Code does not replace existing legislation and policy provisions, e.g. the Code of Conduct for Councillors in terms of the Structures Act, but rather strengthens it. The Code applies to both political and administrative leaders.

- (c) That the council resolution for the adoption of the Code be submitted to the MEC for Local Government in the Western Cape within sixty (60) days of the date of signature on the Circular from DCoG, namely 9 October 2024.
